



No.SO (Boards)13-2/2017/HSSC(A):- Pursuant to the provisions of section 4 of the Punjab Essential Services (Maintenance) Act, 1958 (XXXIV of 1958), I, **Nasim Nawaz**, Secretary to Government of the Punjab, Higher Education Department, being satisfied that the public interest so requires, do hereby order as follows:


- (i) All the persons, employed by a Board of Intermediate and Secondary Education in the Punjab as Superintendents, Deputy Superintendents, Invigilation Staff, Mobile Inspectors, Distributing Inspectors, Resident Inspectors, Paper Setters, Head Examiners and Sub Examiners Shall be on duty according to the duty roster issued by the concerned Board in connection with the Higher Secondary School Certificate (Annual) Examination 2017 commencing on 6th May, 2017.
- (ii) They shall perform their duties as assigned to them by the concerned Board.

02. This order shall come into effect immediately and shall remain in force until conclusion of the said examination or for a period of forty five days, whichever is later.
